### Market Review – 2022-23

#### **Debt Market in FY 2023**

The yield on the 10-year benchmark paper rose 48 bps in FY23 to close at 7.32% compared to the previous fiscal's close of 6.84% after moving in a range of 6.90% to 7.62%. Benchmark paper yield rose for the third consecutive financial year although the pace of rise was slower than previous financial year. Most of the rise in bond yields were witnessed during the first quarter of FY23. Thereafter, yields moved within a narrow range during the remaining part of the financial year.

Initially, bond yields rose as the first half yearly schedule (Apr to Sep 2022) auction of government securities, disappointed market participants. Yields surged and touched at its highest level in nearly three years after the Monetary Policy Committee (MPC) in its first monetary policy review of FY23 modified its monetary stance, after keeping an accommodative tone for almost three years.

Yields further increased at a strong pace after the MPC unexpectedly raised the key policy repo rate for the first time in four years in the second meeting. The MPC hiked the key policy repo rate by 40 bps. Yields rose further after consumer inflation in Apr 2022 reached to a near 8-year high, which increased probability of aggressive rate hikes ahead. Yields rose as higher global crude oil prices putting further pressure on the India's inflation outlook, which worsened the bearish sentiment.

Yields increased thick and fast on concerns that the MPC may raise interest rates on Jun 8 to put a check on rising domestic inflationary pressures. Meanwhile, RBI led- MPC increased the repo rate as per market expectation in the third meeting but did not announced any other liquidity withdrawal measure or raising banks' cash reserve ratio (CRR). Elevated global crude oil prices and higher U.S. Treasury yields increased losses.

Bond yields fell from its peak as losses halved in the second quarter of FY23. Yields fell majorly tracking plunge in global crude oil prices amid concerns over a slowdown in global growth. It raised hopes that domestic inflationary pressures will come down. Yields declined further following easing of consumer inflation for Jun 2022 along with gains in the Indian rupee. Gains increased following decline in the U.S. Treasury yields as the quantum of rate hike by U.S. Federal Reserve (Fed) in the latest policy meeting was as per market expectations. The U.S. Fed chief indicated that it may slowdown the pace of rate hikes in the future meetings which also aided market sentiment. Yields started rising again but within the broad band. Bond yields rose on concerns that the MPC would continue to tighten its monetary policy at an aggressive pace to put a check on rising inflation. MPC raised key policy rates by 50 bps as per market expectations in the fourth meeting and committee expects inflation to remain above 6% in the first three quarters of FY23. Yields also went up after the U.S. Fed raised interest rates by 75 bps in its monetary policy review and signaled more rate hikes in the coming months.

Losses increased after consumer price index-based inflation in U.S. rose in Aug 2022 contrary to market expectations. The 10-year U.S. Treasury yield hit 4% for the first time since April 2010, which fueled concerns of foreign fund outflow from the domestic debt market. Yields rose tracking rise in the U.S. treasury yields that crossed 4% mark. Stronger U.S. dollar index that triggered the Indian rupee to touch record low further impacted the bond market. The U.S. Fed remained hawkish in their monetary policy review, which indicated higher terminal rates in the near future.

Yields fell in Nov month on upbeat U.S. inflation and India's inflation slowed in Oct 2022. Strengthening of the rupee against the greenback, boosted market sentiments. Stronger-than-expected demand at the weekly government debt auction and state government auction in Nov month, indicated strong demand. Gains increased after minutes of the US Fed's Nov 2022 meeting indicated slower pace of rate increases from Dec 2022 and tracking fall in global crude oil prices.

Yields rose after the MPC in its monetary policy review raised key policy repo rate by 35 bps in the fifth meeting and highlighted concerns over domestic inflationary pressures. Losses increased after the U.S. Fed increased interest rates in its monetary policy review and added that interest rate hikes in U.S. would continue for a longer period.

Yields increased further mainly tracking rise in the U.S. Treasury yields on upbeat U.S. economic data that raised fears of another rate hike by the U.S. Fed. Yields also rose after the MPC raised key policy repo rates by 25 bps in its sixth monetary policy review and kept the door open for further rate hikes as it was of the view that core inflation remained at elevated level.

#### **Equity Market in FY 2023**

Domestic equity markets closed on a mixed note in FY23 as S&P BSE Sensex went up by 0.72% while Nifty 50 fell 0.60%. The entire year was marred by significant volatility as both the mid-cap segment and the small cap segment closed the fiscal in red. It was a roller-coaster rise for the domestic equity markets which hardly returned any gains to investors. Markets faced multiple headwinds during the year namely COVID-19 pandemic in China, decade high inflation in U.S. and Europe, aggressive monetary policy tightening by central banks across the globe, geopolitical conflict between Russia and Ukraine, renewed tensions between U.S. and China and turmoil in the U.S. banking sector.

Markets remained under pressure at the beginning of the year as the COVID-19 pandemic wreaked havoc and continued to spread like wildfire in China, thereby raising questions over the country's zero covid policy. It was the worst COVID-19 outbreak in China as multiple cities were under full or partial lockdown which contributed significantly towards the country's GDP. The COVID-19 outbreak in China led to worries of a slowdown in global growth. Geopolitical tensions between Russia and Ukraine also weighed on the market sentiment. The conflict caused tectonic shifts which led to fresh challenges for global growth. The Russia-Ukraine war resulted in sanctions and retaliatory actions which led to shortages and supply dislocations. Supply chain disruption led to in volatility in commodity and financial markets. Global crude oil prices which were just above 60\$/barrel at the end of FY21 skyrocketed by more than 100% and surpassed the 120\$/barrel in May 2022 and remained around 100\$/barrel till the beginning of Nov 2022. Increase in global crude oil prices is credit negative for the Indian economy as India imports more than 80% of the oil requirements.

Geopolitical tensions ratcheted up inflation to their highest levels in the last 3 to 4 decades in major economies with external demand moderating. Inflation sensitive items relevant to India such as edible oils were in short supply due to the Russia-Ukraine war and export bans by key producers. This coupled with an increase in fertilizer prices and other input costs led to an increase in food inflation. Increase in food inflation led to increase in domestic inflationary pressures within the Indian economy which weighed on the market sentiment.

The consumer price index based inflation rose to a near 8-year high of 7.79% in Apr 2023 and remained above the upper tolerance level of 6% for majority of the fiscal. Higher retail inflation nudged the Reserve Bank of India (RBI) led Monetary policy Committee (MPC) to tighten its monetary policy. The RBI led MPC embarked on a rate hiking spree from May 2022 and raised key policy repo rate by 250 bps during the entire fiscal from 4% to 6.50%. The repo rate thus stood at the highest level since Feb 2019. MPC also changed its stance on its monetary policy as it was no longer accommodative and decided unanimously to remain focused on withdrawal of accommodation.

Major central banks across the globe also started to tighten their monetary policy at an aggressive pace both in terms of rate hikes and gradual unwinding of quantitative easing to put a check on rising inflation which was running at multi-decade high levels. The faster pace of monetary policy tightening led to heightened volatility in global financial markets which was reflected through sizeable swings in sovereign bond yields, volatile currency fluctuations and capital outflows.

The U.S. Federal Reserve raised increased interest rates by 450 bps in FY23. The Bank of England and the European Central Bank also followed suit as they raised interest rates by 350 bps in the same fiscal. Thus, rising interest rates, higher inflation and elevated commodity prices were the two main challenges faced by the domestic equity markets in FY23. Also ebbing of pent up demand post COVID-19 pandemic created pressure on sales and margins to some extent.

Worries of a global recession due to higher inflation and aggressive monetary policy tightening by central banks across the globe kept the investor risk sentiment muted. World Bank warned that the global economy could be edging towards a recession in 2023. The Asian Development Bank downgraded the growth projections of the Indian economy for FY23 to 7% from 7.5% estimated in Apr 2022. The International Monetary Fund downgraded India's economic growth forecast to 7.4% from 8.2% for FY23 citing the domestic economy's vulnerability to external shocks and rapid monetary policy tightening.

Domestic equity markets exhibited resiliency and bounced back to some extent in the interim on the back of upbeat domestic macroeconomic data. India's Q1FY23 real GDP grew by 13.5%, aided by private consumption growth. GST revenue collections remained upbeat as monthly GST revenues of

more than Rs. 1.4 lakh crore was collected for 12 months in a row. Both manufacturing PMI and services PMI remained above 50 indicating expansion in economic activity. Also, companies across multiple sectors reported upbeat earning numbers for the quarter ended Jun 2022 and Sep 2022.

Domestic demand improved as the festive season kicked in which also improved the overall market sentiment. Inflation showed signs of moderation indicating that monetary policy tightening was having the desired impact of putting a check on rising inflation. Bargain hunting further aided market sentiment as market valuations turned favourable after the recent spate of corrections. Market participants were of the view that despite the global headwinds, India was in a relatively sweet spot relative to other peer emerging economies.

On the global front, a slew of positive developments also helped the domestic equity market to recover some of the losses. China decided to do away with its quarantine requirement for inbound travelers starting Jan 8, 2023 which led to hopes of normalcy in China's economy and improved prospects of demand recovery. Concerns over the ongoing geopolitical tension between Russia and Ukraine eased to some extent after the Russian President reportedly said that Russia was open to negotiations over the war in Ukraine and that Russia was ready to resume gas supplies to Europe through the Yamal-Europe Pipeline, that were closed earlier this year amid the Ukraine war. Hopes of easing US-China tension further contributed to the upside after the American and Chinese presidents met during the G20 summit. Market participants remained hopeful for an easing of U.S.-Chinese tension over security, trade, technology, and human rights.

Domestic equity markets failed to hold on to the momentum and witnessed volatility after a U.S. based research firm expressed concerns regarding corporate misgovernance and the use of extreme leverage by an Indian multinational conglomerate. Losses were extended after a major global index provider lowered the free-float designations for four of the companies of the Indian multinational conglomerate. However, further losses were restricted after the Indian multinational conglomerate took steps to restore investors' trust. Markets also gave thumbs up to the Union Budget 2023. The government in the Union Budget increased its outlay on capital expenditure, significantly raised its spending on infrastructure, announced income tax sops for particularly younger taxpayers and at the same time adhered to the fiscal consolidation roadmap which boosted market sentiments. No change in capital gains structure as feared by the market was also a big relief.

The sell off in the domestic equity markets deepened towards the end of the fiscal as crisis at a major private sector bank in U.S. dampened investors' sentiment. According to media reports, it is the biggest retail banking failure in U.S. since the 2008 global financial crisis. Liquidity concerns over a major global investment bank and financial services firm founded and based in Switzerland also kept sentiments muted. Sentiments were further hit after the Indian government hiked securities transaction tax on futures and options contracts, along with other amendments in Finance Bill 2023. According to the amendments made in the Finance Bill, no benefit of indexation will be applicable for debt mutual funds for calculation of long term capital gains tax. The same will be applicable for investments made on or after Apr 1, 2023. Also, such debt mutual funds who invest less than 35% of their assets in equities will be subject to short-term capital gains tax.

However, worries over the stability of the global banking sector eased to some extent after the U.S. Federal Reserve, the U.S. Treasury, the Federal Deposit Insurance Corporation, a consortium of major U.S. private banks and the Swiss Central Bank acted timely and took steps to contain the banking crisis and calm the markets. Fall in global crude oil prices also aided market sentiment. Global crude oil prices fell over the year as worries of a potential global recession hit the demand outlook of the commodity.

#### Outlook

#### Debt

Bond yields are expected to be triggered in FY24 due to two major reasons- high government borrowings in the first half of FY23 and RBI's interest rate trajectory. MPC in its first policy review of FY24 surprised the market by not raising interest rates for the first time after six consecutive rate hikes. Easing domestic consumer inflation is favouring stable to lower policy rates in FY24. Also future policy moves of the Reserve Bank of India likely to be guided by the policy decision and commentary of the U.S. as the U.S. central bank in the last meeting indicated to pause the rate hike cycle. On the other hand, higher government borrowings may lead to higher bond supply in the market. On a positive side, despite higher scheduled borrowings, government weekly auctions till now have sailed through smoothly without any devolvement and not much impact on bond yields. Market participants will also track the movement in the U.S. treasury yields, which impacts the movement in the Indian bond market. This apart global crude oil prices going forward, can also trigger movement in the bond yields.

#### **Equity**

Domestic equity markets moving ahead will track as to what stance the central banks take in their upcoming monetary policy reviews amid signs that global inflation has peaked. Corporate earning numbers for the quarter ended Mar 2023 will also be closely tracked as the same will provide cues regarding the stability and resiliency of the domestic economy. In addition, incoming domestic macroeconomic data is also expected to impact market sentiment. On the global front, global crude oil prices will also be on the investors' radar as India imports more than 80% of its oil requirements and increase in global crude oil prices is credit negative for the Indian economy. In addition to the above mentioned factors, movement of the rupee against the greenback and transaction trends by foreign institutional investors may also have its impact on the domestic equities.

#### Risk Management at Bharti AXA Life

The company also diversifies its stock portfolio across industries to reduce risk. The key risk management policy adopted is maintaining high standards of credit quality of the portfolio and maintaining optimum duration depending on the market outlook. We also believe that discipline is critical in managing funds over a longer tenure. We have therefore set different benchmarks for the funds we manage and fund performance is closely monitored against the set benchmarks. We strive to generate higher risk-adjusted returns over a longer period of time.

A reasonable level of liquidity is maintained with the respective funds so as to enable smooth redemption process on account of switches, claims etc. This is followed in line with the liquidity norms prescribed in our investment policy manual.

To sum up, our endeavor is to generate for our policyholders, consistent, risk-adjusted returns in a disciplined and repeatable manner with the aim of beating the defined benchmarks by active fund management.
